Business

A court order authorizing to scrap a printer was presented and approved by Presiding Commissioner Nelson, Commissioner Burnham, and Commissioner Hook.

A court order authorizing a change order for Scott Gann Construction was presented and approved by Commissioner Burnham, Commissioner Hook, and Presiding Commissioner Nelson.

Court orders selling trustee properties were presented and approved by Commissioner Burnham, Commissioner Hook, and Presiding Commissioner Nelson.

At 8:55 am Natalie Mummert, Steve Mummert, Bernard Chestnut, Road and Bridge East Supervisors Brian Burnett, Jerry Gill, Planning and Zoning Supervisor Kristy Theas, GIS Marcus Larson and County Attorney Josh Bachman joined the meeting about a road issue on SE 110th along Castile Creek near Hwy 116. Natalie explained the logistics of the land and showed where property lines were and explained they petitioned to close the road in 2003 in which a court order was processed to abandon the road. Ther Mummert's asked this Commission to open/establish the road now. Commissioner Burnham explained it's not that simple, there are no properties on this abandoned road, and it goes nowhere or doesn't connect to another road. If a house is ever on this land, it will only become a driveway, not a road. County Attorney Josh Bachman added that they would have to get a petition to establish a road and all the landowners will have to front the cost for the road. Natalie Mummert, Steve Mummert, Bernard Chestnut, Planning and Zoning Supervisor Kristy Theas, GIS Marcus Larson left the meeting at 9:40 am.
