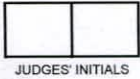

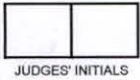

SCHOOL DISTRICT**

**SPECIAL SCHOOL LEVY ELECTION
PROPOSITION 1**

Shall the Board of Education of the East Buchanan County C-1 School District, Missouri, be authorized to increase the operating tax levy by \$0.6500 to \$5.8736 per one hundred dollars of assessed valuation through Tax Year 2042 in order to provide funds for the construction, equipping, and furnishing of a new Middle School; to complete other repairs and improvements to the existing facilities of the District; and to meet the additional operating needs of the District?

(If this proposition is approved, the adjusted operating tax levy of the District is estimated to increase by \$0.6500 from \$5.2236, currently, to \$5.8736 per one hundred dollars of assessed valuation for Tax Year 2023 and can be applied to the assessed valuation for each year thereafter through Tax Year 2042.)
